Our Work

Children removed from their home because of abuse or neglect face a frightening, profound unknown, and we make sure they don't face it alone. CASA (Court Appointed Special Advocate) helps these child victims heal and thrive, through a dedicated, one-on-one relationship. Louisiana CASA, together with local member programs, supports and promotes court-appointed volunteer advocacy so every child who has experienced abuse or neglect can be safe, have a permanent home, and the opportunity to thrive.

We are a group of staff and volunteers that advocate for the best interests of children in the foster care system. Louisiana CASA is the statewide association for the 18 local CASA programs across the state. We work in courtrooms across the state and serve over 3,000 of Louisiana's most vulnerable children.

CASA has been endorsed by the American Bar Association, the National Council of Juvenile and Family Court Judges, and the Office of Juvenile Justice and Delinquency Prevention of the U.S. Department of Justice.

Our Impact

Whatever their age, children who have experienced abuse or neglect face a frightening, profound unknown. Courtrooms. Foster care. New schools. **We make sure they don't face it alone.** To make a decisions that affect the rest of a child's life, judges need to know the child. Our highly trained Court Appointed Special Advocate (CASA) volunteers help them do that by getting to know the child at the heart of each case and gathering details to help the judge determine the best interests of the child. **CASA advocates help these child victims heal and thrive through a dedicated, one-on-one relationship.** Below are last year's statewide statistics, reflecting the powerful impact of CASA volunteers on the lives of children in foster care.

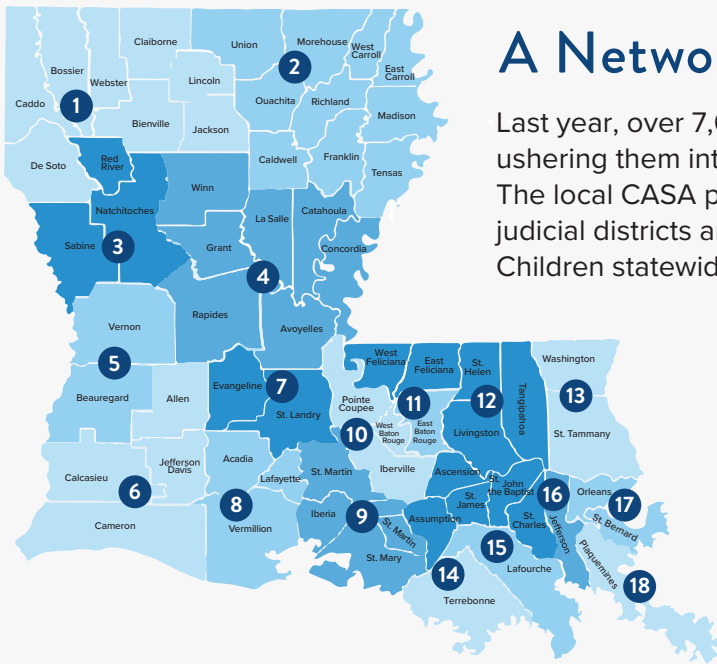

A Network of Volunteers for Children

Last year, over 7,000 children in Louisiana experienced abuse or neglect, ushering them into the dependency of the court and foster care systems. The local CASA programs work in dozens of court room across the state's judicial districts and advocate for Louisiana's most vulnerable children. Children statewide have access to a dedicated CASA volunteer.

CASA Makes a Life-Long Impact

Independent, national research identified the effectiveness of CASA advocates serving abused and neglected children. Highlights of the findings show that a child with a CASA:

- Is more likely to spend less time in foster care.
- Is half as likely to re-enter the child welfare system.
- Is more likely to do well in school and perform better academically.
- Shows significantly higher levels of hope.

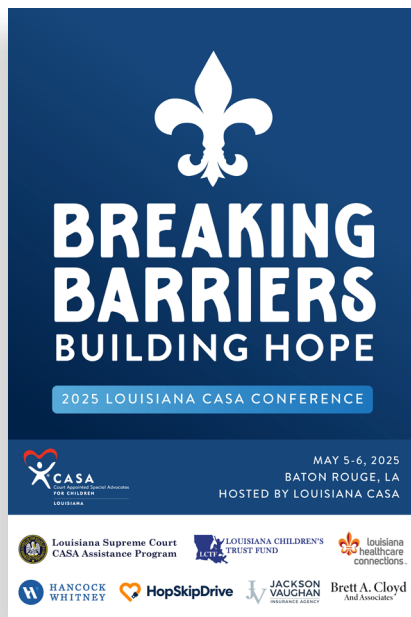

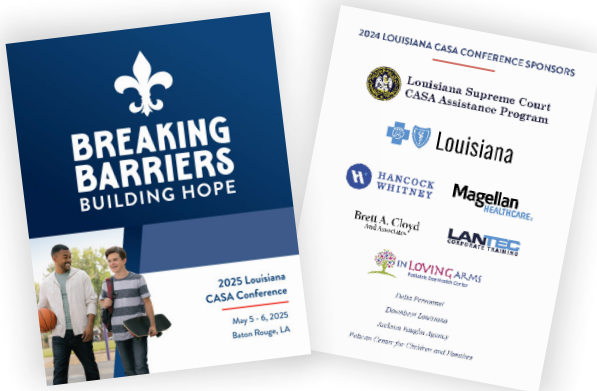
