CASA Serves Children in Crisis

Whatever their age, children who have experienced abuse or neglect face a frightening, profound unknown. Courtrooms. Foster care. New schools. **We make sure they don't face it alone.** To make a decisions that affect the rest of a child's life, judges need to know the child. Our highly trained Court Appointed Special Advocate (CASA) volunteers help them do that by getting to know the child at the heart of each case and gathering details to help the judge determine the best interests of the child. **CASA advocates help these child victims heal and thrive through a dedicated, one-on-one relationship.** Below are last year's statewide statistics, reflecting the powerful impact of CASA volunteers on the lives of children in foster care.

OUR ADVOCACY

CASA advocates improve the quality of judicial decision-making by providing unique, up-to-date information that could only come from a one-on-one relationship between a child and a dedicated volunteer. CASA volunteers monitor the child's case, working with all parties in the courtroom to ensure the child receives every evaluation, treatment, and service ordered by the judge.

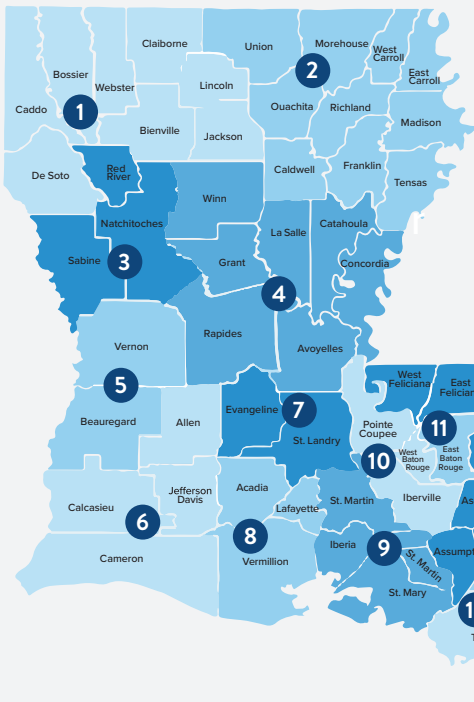


Louisiana CASA is the statewide association for the 17 local CASA programs.

A Network of Volunteers for Children

Last year, over 7,000 children in Louisiana experienced abuse or neglect, ushering them into the dependency of the court and foster care systems. The local CASA programs work in dozens of court room across the state's judicial districts and advocate for Louisiana's most vulnerable children. Children statewide have access to a dedicated CASA volunteer.

CASA Makes a Life-Long Impact

Independent, national research identified the effectiveness of CASA advocates serving abused and neglected children. Highlights of the findings show that a child with a CASA:

- Is more likely to find a safe, permanent home, spending less time in foster care.
- Is half as likely to re-enter the child welfare system.
- Is more likely to do well in school and perform better academically and behaviorally.
- Shows significantly higher levels of hope.
